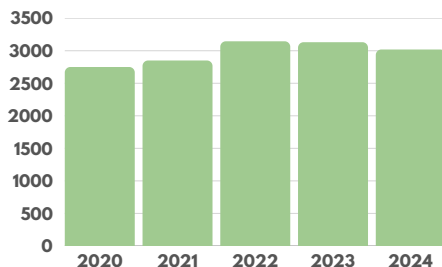

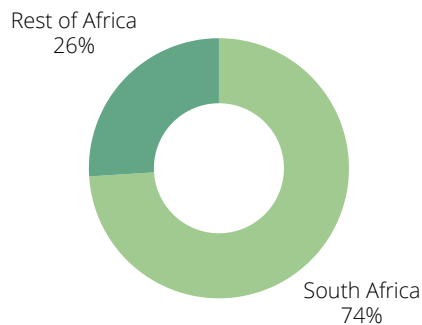
## GROSS WRITTEN PREMIUM
